

# From Tweets to Thrills: The Evolution of Digital Storytelling on YouTube through Nessie Judge's Horror Narratives

## Abstrak

Studi ini mengeksplorasi evolusi penceritaan digital di YouTube dengan menggunakan konten Nessie Judge sebagai studi kasus. YouTube, sebagai platform, telah mengubah interaksi penonton dari konsumsi pasif menjadi keterlibatan aktif, memungkinkan pemirsa untuk merespons dan berinteraksi langsung dengan konten. Nessie Judge mencontohkan perubahan ini dengan seri horor populernya, "Cerita KKN Desa Penari," yang berasal dari tweet viral dan memikat jutaan penonton. Ceritanya menggabungkan narasi yang menarik, bantuan visual, dan bukti, meningkatkan keterlibatan penonton. Penelitian ini menggunakan pendekatan deskriptif kualitatif, menganalisis video Nessie untuk memahami tekniknya dalam melibatkan pemirsa. Temuan ini menyoroti pentingnya penceritaan yang efektif dalam pembuatan konten digital dan dampaknya terhadap retensi dan keterlibatan audiens di platform seperti YouTube. Popularitas penceritaan digital yang meningkat sebagian besar disebabkan oleh kemajuan teknologi yang membuat pembuatan konten lebih mudah diakses. Di Indonesia, YouTuber lokal seperti Nessie Judge dan Nadia Omara telah berperan penting dalam mempopulerkan media ini dengan mengintegrasikan budaya lokal ke dalam narasi mereka. Konten bertema horor Nessie Judge, khususnya cerita seperti "KKN Desa Penari," secara efektif melibatkan penonton dengan menggabungkan penceritaan yang mendebarkan dengan cerita rakyat budaya. Interaksinya dengan penonton melalui komentar dan media sosial memperkuat koneksi dan loyalitas penonton. Studi ini menyoroti bagaimana penceritaan digital tidak hanya menghibur tetapi juga memperdalam keterlibatan budaya, menggambarkan dampak transformatif dari pembuatan konten yang personal dan interaktif pada keterlibatan dan pengalaman naratif audiens.

#### Abstract

This study explores the evolution of digital storytelling on YouTube, using Nessie Judge's content as a case study. YouTube, as a platform, has transformed audience interaction from passive consumption to active engagement, enabling viewers to respond and interact directly with content. Nessie Judge exemplifies this shift with her popular horror-themed series, "Cerita KKN Desa Penari," which originated from a viral tweet and captivated millions of viewers. Her storytelling combines compelling narratives, visual aids, and evidence, enhancing audience immersion. This research employs a qualitative descriptive approach, analyzing Nessie's videos to understand her techniques in engaging viewers. The findings highlight the importance of effective storytelling in digital content creation and its impact on audience retention and engagement on platforms like YouTube. The rising popularity of digital storytelling is largely due to technological advancements, making content creation more accessible. In Indonesia, local YouTubers like Nessie Judge and Nadia Omara have been pivotal in popularizing this medium by integrating local culture into their narratives. Nessie Judge's horrorthemed content, particularly stories like "KKN Desa Penari," effectively engages audiences by blending suspenseful storytelling with cultural folklore. Her interaction with viewers through comments and social media strengthens audience connection and loyalty. This study highlights how digital storytelling not only entertains but also deepens cultural engagement, illustrating the transformative impact of personal and interactive content creation on audience engagement and narrative experience.

## **INTRODUCTION**

As one of the largest online video platforms, YouTube offers various types of videos, all aimed at indulging its audience. From music videos, tutorials, entertainment, and informational content to vlogs showcasing daily life, these diverse forms of content are presented on this platform. Recently, YouTube videos have become increasingly popular and are often used as both information and entertainment media for all segments of society. As viewers, we are required to skillfully discern the information presented in YouTube content.

The advancement of technology and the emergence of platforms like YouTube have fundamentally transformed the way audience-media interactions occur. YouTube not only offers diverse media content but also transforms the nature of interactions into more interactive and dynamic forms. Here, the audience is no longer a passive viewer who merely receives messages in one direction, as often happens in conventional television. Instead, YouTube enables the audience to directly respond through comments, likes, dislikes, and various other forms of interaction.

YouTube serves as a prime illustration of a broader paradigm shift within the media landscape, where audiences have transitioned from passive consumers to active content producers, empowered to upload videos and articulate their own narratives. This transformation engenders a more egalitarian dynamic in the media ecosystem, fostering the proliferation of diverse voices, perspectives, and narratives free from undue influence by dominant entities. Concurrently, the evolution of communication technologies, exemplified by platforms like YouTube, has facilitated the emergence of digital storytelling, wherein content creators harness the platform's capabilities to craft narratives. Digital storytelling, as a mode of mediated communication, harnesses an array of information and communication technologies to facilitate the dissemination of information, packaged within various thematic frameworks characterized by engaging presentation styles (Thurlow, Lengel, & Tomic, 2004; Maddin, 2011). Within this realm, narratives are typically conveyed within concise temporal constraints, reflecting the evolving dynamics of media consumption and production in the digital age.

Nessie Judge, a YouTube content creator with a subscriber count of 9.86 million, presents one such of digital storytelling One of her popular video contents is titled "*Kasus Viral KKN di Desa Penari*!" ("Viral Case of Internship Program in Penari Village!"), specifically the episode "*Neror*." This episode has captured the attention of YouTube users, garnering 22 million views since four years ago. Nessie Judge's storytelling style keeps her



YouTube subscribers eagerly anticipating the continuation of the narrative. Notably, the "Cerita KKN Desa Penari" ("Story of the Penari Village Internship Program") video began as a viral tweet on Twitter, and Nessie managed to bring this story to life, engaging the audience and sparking their curiosity to learn more about the story. In her storytelling process, Nessie often provides valid evidence along with a well-defined perspective on the narrative. The horror genre of the "Cerita KKN Desa Penari" story is effectively conveyed through the use of a supporting horror-themed video background, further immersing the listeners in the atmosphere.

The content under scrutiny pertains to tweets concerning a community service program (KKN) in Penari Village disseminated by the Twitter account @simplem81378523, which subsequently gained viral traction in 2019. Despite lacking definitive verification, many individuals maintain the belief that this narrative represents a factual account. The 30-minute video commences with Nessie Judge introducing the characters involved in the narrative, including Ayu and five other KKN students named Widia, Nur, Ayu, Bima, Anton, Wahyu, alongside other personas such as Pak Prabu, Mbah Buyut, and Mas Ilham (all identities depicted in the video are pseudonymous). The proliferation of this content can be attributed to a synergistic combination of Nessie's established credibility and her adept utilization of persuasive communication techniques as a content creator. Drawing from the captivating manner in which Nessie Judge delivers her narrative, eliciting a profound sense of curiosity among a sizable audience regarding the "Cerita KKN Desa Penari" video, it can be inferred that viewers effectively comprehend the conveyed content, thereby augmenting their knowledge base. Nessie's videos, particularly her series on the viral case of the internship program in Penari Village, have garnered immense attention, evidenced by the millions of views they have accumulated over the years. Nessie's storytelling technique keeps her audience eagerly anticipating the next installment, a testament to her skill in engaging viewers. Notably, the narrative originally surfaced as a viral tweet on Twitter, but Nessie adeptly transformed it into an immersive video series that captivated her audience's imagination. Nessie's storytelling prowess lies in her ability to provide a compelling narrative supported by evidence and a distinct perspective. Her videos effectively convey the horror genre through the use of appropriate visuals and atmosphere, further enhancing the audience's immersion in the story. Moreover, Nessie introduces the characters involved in the narrative, adding depth and intrigue to the storyline.



The popularity of Nessie's content can be attributed to her credibility as a content creator and her persuasive communication style. Through her engaging delivery, she successfully piques the curiosity of her audience, prompting them to delve deeper into the storyline and expand their understanding. This phenomenon underscores the power of effective storytelling in attracting and retaining viewers on platforms like YouTube. Therefore, Nessie Judge's success on YouTube underscores the significant role of storytelling in captivating and retaining viewers. Her ability to blend credibility with persuasive communication techniques creates a compelling narrative experience that resonates with her audience. By delving into the intricacies of her storytelling technique in the "Cerita KKN Desa Penari" series, this research aims to uncover the mechanisms behind Nessie's ability to attract and engage viewers on YouTube. Through a thorough analysis of her narrative style, use of evidence, and engagement strategies, this study seeks to contribute to our understanding of effective content creation in the digital era.

#### **METHOD**

This research adopts a qualitative method, drawing from the definition provided by Nutman, Miller, Milligan, and Ottesen (1986), who characterize qualitative research as a distinct tradition within the social sciences predicated on the observation of human behavior, both within their natural environments and through their language usage. Within this framework, qualitative research serves as a means to elucidate and describe the collected data, which encompasses observed behaviors and textual materials (Rakhmat, 2005). The chosen approach for this study is descriptive in nature, aiming to provide a detailed account of the phenomena under investigation. Data collection is conducted through a multifaceted approach involving literature review and documentation.

Firstly, a comprehensive review of existing literature is undertaken to contextualize the subject matter and identify relevant theoretical frameworks. This literature review encompasses scholarly articles, books, and other pertinent sources related to digital storytelling, YouTube content creation, and audience engagement. Additionally, documentation of relevant materials sourced from YouTube, particularly the videos produced by Nessie Judge, forms a crucial aspect of data collection. These documents may include video transcripts, comments, likes/dislikes ratios, and other metadata associated with the videos.

Furthermore, observation of Nessie Judge's YouTube videos constitutes the primary source of data in this research. By systematically watching and analyzing the content of her

videos, insights into her storytelling techniques, presentation styles, and audience engagement strategies can be gleaned. This observational approach allows for a nuanced understanding of how digital storytelling unfolds in practice and how it resonates with audiences. Subsequently, the collected data is subjected to analysis using the Miles and Huberman analysis technique. This method involves a systematic and iterative process of categorizing, sorting, and synthesizing the data to identify patterns, themes, and relationships. Through this analytical framework, the researcher can derive meaningful insights and draw conclusions regarding the effectiveness of Nessie Judge's storytelling technique in engaging YouTube audiences

### **RESULT AND DISCUSSION**

# YouTube and Digital Storytelling

With the advancement of communication technology and internet speed, an increasing number of content creators are emerging, utilizing audiovisual media to reach their audiences. The power of digital storytelling lies in its ability to create multifaceted multimedia experiences. Platforms such as YouTube provide a stage for storytelling by incorporating a combination of film, graphics, photography, and audio recordings. Each mode of communication serves different purposes, yet together, they form a cohesive and integrated narrative entity (Meyer, Höllerer, Jancsary, & Van Leeuwen, 2013).

Some content creators have made storytelling their selling point, with names like Nessie Judge, Nadia Omara, Hirota Radifan, and Korean YouTuber Jang Han Sol (Korea Roemit) garnering large subscribers by leveraging narrative, especially horror stories, criminal cases, and viral content, as strengths in their videos. The following is a summary of the characteristics of each content creator:

From the table above, Nessie Judge is the content creator with the largest number of subscribers, totaling more than 10.5 million. Nessie Judge is capable of enchanting the audience with simple and easily understandable language. According to Nicoli, N., Henriksen, K., Komodromos, M., & Tsagalas, D. (2022), content creators who are able to engage with their audience should present clear language, uplifting music, and the use of text within the video. Audience engagement can be observed through the abundance of comments on the video, and these discussions are even carried out on other platforms such as Twitter and Instagram.



# Nessie Judge Content: Audience Engagement and Local Value

The surge in the popularity of digital storytelling over the past decade can be partially attributed to the availability of technological infrastructure, rendering projects of this nature far more feasible today, ranging from affordable video recording to the widespread availability of video editing software (Godwin-Jones, 2012). In Indonesia, the popularity of YouTubers and local content creators has also contributed to this phenomenon. Individuals such as Nessie Judge and Nadia Omara, who create content with themes and styles closely aligned with local culture, have played a significant role in introducing digital storytelling to the Indonesian populace. One of Nessie Judge's content pieces involves horror narratives, with a particularly intriguing story being the case of a group of students on a community service program (KKN) in the Klaten area who stayed in an empty house. Nessie astutely chose to highlight this narrative due to the contemporaneous discussion surrounding community service activities, particularly following the release of the successful film "KKN Desa Penari," which garnered considerable viewership. In this content, the storyline of the community service program is vividly articulated and capable of evoking tension among viewers. This may be attributed to Nessie's adeptness in storytelling, which consistently captivates audiences in each of her horror-themed content pieces.

Their content often encompasses mystical or supernatural stories inspired by local beliefs and legends, such as the tale of KKN in Desa Penari previously discussed by Nessie Judge in one of her contents. By exploring these mystical aspects, content creators are able to attract greater interest and involvement from Indonesian audiences, who often possess a strong emotional attachment to local cultural heritage and myths. This not only enriches their viewing experiences but also strengthens their connection to local digital content, thereby propelling the overall growth of digital storytelling in Indonesia.

The potency of personal engagement with the audience, coupled with the closely intertwined local cultural values and the personal experiences of the audience, fosters a sense of familiarity with the Indonesian cultural milieu. It is unsurprising that comments on Nessie Judge's videos often depict experiences shared by the audience. In this context, Sanchez-Lopez, I., Perez-Rodriguez, A., & Fandos-Igado, M. (2020) posit that users assume a central role, capable of nurturing, enriching, and prolonging the life of narratives, both within the diegesis and in the real world. Contemporary narrative structures offer the potential to connect with external narrative elements, nodes that exist within non-human applications and are activated at the author's discretion due to technological advancements. Nessie Judge cultivates



a rapport with her audience through direct interactions in comments, responses to queries, or even through other content on social media or other platforms.

The manner in which Nessie Judge responds or interacts with her audience can be pivotal in shaping a positive perception of her as a content creator. Prompt, amiable, and authentic responses to comments, queries, or feedback from viewers can engender feelings of being valued and heard. This not only fortifies the bond between Nessie and her audience but also aids in building a dedicated fan community or following. According to Daniel, Jackson, & Westerman (2018), viewers feel connected to their favorite influencers due to the ability for small-scale interactions facilitated by social media platforms. Nessie utilizes her social media platforms, such as Instagram, Twitter, or the YouTube Community tab, to directly communicate with her fans, disseminate the latest information, share behind-the-scenes anecdotes, or even solicit preferences from the audience regarding future content.

Overall, active and authentic interactions between Nessie Judge and her audience can serve to bolster their relationship, forge loyal fan communities, and enhance Nessie's image as a caring and responsive content creator attuned to the needs and desires of her fans. By immersing the audience into the narrative realm, the content creator establishes an additional layer of intimacy. This intimacy, distinct from the parasocial relationship often found in other video creators where the audience connects solely with the host, stems from the personal engagement with the story and its characters. By integrating the audience into the physical world of the audio drama's narrative, the content creator fosters a similar sense of closeness to the material, enhancing the overall experience. (Sumida-Tate, 2022). The success of Nessie Judge as a prominent content creator is not solely based on a large subscriber base but also on her ability to effectively engage with her audience through captivating narratives. By continuously exploring avenues to enhance audience engagement through the use of audiovisual elements, Nessie's content has demonstrated that profound viewing experiences are not merely about entertainment but also about forging a strong bond between content creators and viewers.

# **Digital Popular Horror Narratives**

In recent years, there has been an increase in the production of horror films, TV series, and online content in Indonesia. This has helped to further cultivate public interest in this genre. Powell (2017) suggests that advancements in technology have not only influenced the development of the horror genre but have also transformed it into a digital storytelling form. This transformation is driven not only by technology's role in facilitating the creative process



and accessibility but also by its impact on business models, which have shifted horror into the digital realm. This phenomenon also indicates that horror content has become a highly sought-after digital commodity by audiences, as evidenced by the high engagement levels with contents such as "KKN di Desa Penari" produced by Nessie Judge. Simultaneously, folklore remains an integral part of horror culture, shaping its traditions, forms, and emotional foundations. From orally transmitted myths to printed fables and recorded legends, folklore has played a key role in many famous stories within the horror genre. This is evident in Indonesian horror narratives such as "KKN di Desa Penari," where folklore elements are intricately woven into the storyline, adding layers of authenticity and cultural resonance. These narratives serve as modern companions to ancient myths, aiming to both frighten and reassure audiences by giving shape and dimension to the unknown, making it more understandable within the context of Indonesian cultural heritage.

Why do Indonesian audiences enjoy horror content? One reason is because Indonesia is rich in culture, mythology, and mystical stories. Many Indonesians grow up with spooky tales passed down from generation to generation. This creates a deep interest in all things horror and supernatural. Additionally, for some people, watching or reading horror content provides a unique adrenaline rush and tension. It feels like facing fear without actually being in danger, which can be a thrilling and satisfying experience. Furthermore, according to adhair, Massa, Skandrani (2020), locally themed horror content fosters homophily, which is the similarity of individuals interacting in beliefs, education, social status, and the like. Homophily has been recognized for its ability to enhance communication effectiveness. If two individuals share many similarities, communication between them will be stronger. When content closely relates to local culture, it creates similarity or homophily between the content creator and their audience. Audiences feel connected to the content because the stories and experiences shared enrich their cultural identity. It's not just about watching stories but also about feeling a connection with the content because it reflects values, traditions, and experiences familiar to the audience. For example, when content explores mystical stories or local legends, audiences from the same region or with similar cultural backgrounds feel more connected to the story. They can experience the same admiration or fear as the characters in the story because they have a deeper understanding of the cultural background and story context.

The story of KKN is highly relevant to the experiences of Indonesian society, not only in terms of its horror aspects but also in terms of the experience as KKN students who often face situations beyond reason and the routines of urban students. KKN participants are often



confronted with unexpected challenges, including mystical events and interactions with supernatural beings, creating a KKN experience that is far from ordinary. This content builds an alternative version of reality, where supernatural elements and mysteries dominate. Through depictions of strange occurrences and interactions with supernatural beings, the narrative creates an image of Desa Penari as a place filled with supernatural energy. However, despite the generally high quality of audio and visual elements in the content, there are some shortcomings in the editing process, such as the addition of images and room illustrations that sometimes disrupt the storyline and the intended horror impression.

Nessie Judge uses language and communication style appropriate to her content genre. She employs dramatic or tense words or phrases to build tension and fear in her narration, including the use of engaging and evocative language, appropriate intonation, and emphasis on key moments in the story. A strong narrative style can be a driving force in maintaining audience interest and engagement.

Nessie Judge's persona is intricately woven through her on-camera portrayal, encompassing facial expressions, body language, and physical demeanor. The coherence and authenticity of her presentation foster a sense of connection between the audience and her individuality, transcending mere narratorial roles. As a purveyor of content, Judge wields considerable influence in shaping the audience's perceptions and convictions regarding the narratives she conveys. The veracity of her portrayal as a narrator or storyteller assumes paramount significance in engrossing and retaining audience engagement.

While certain scenes may evoke tension in viewers, the overall composition of Nessie Judge's videos, particularly in the narrative of "KKN di Desa Penari," fails to evoke profound fear. Nonetheless, this renders her content more palatable to viewers less inclined towards the horror genre but still intrigued by popular narratives like "KKN di Desa Penari." Consequently, this video serves as a reference point for audiences averse to horror genres or newcomers seeking a deeper understanding of Nessie's content.

As a content creator, Nessie Judge constructs her unique identity within the framework of "Nessie Judge KKN di Desa Penari." This identity encompasses narrative style, on-camera presentation, and interactions with her audience. Nessie Judge's image as a purveyor of horror or mystery may be cultivated through an emphasis on dark, tense atmospheres, coupled with the utilization of cinematic techniques or editing methods that amplify a sense of mystery. The horror content produced by Nessie Judge, particularly in the narrative of "KKN di Desa Penari," elicits a multifaceted response from the audience. Digital storytelling not only fulfills



entertainment needs but also creates space for cultural exploration and broader creativity within specific contexts.

Visually, in the summary video of "KKN di Desa Penari," Nessie adopts a monochromatic style, clad in predominantly black and gray attire and accessories, a commonality among horror content creators. Nevertheless, the presence of white walls and bright lighting in the video imparts a less foreboding impression, thus making it more approachable for viewers averse to the horror genre. Nonetheless, Nessie interjects certain visual elements throughout the video that induce moments of surprise to bolster narrative delivery, such as illustrations of genderuwo, ghostly grandmothers, and depictions of rigid, gaping figures. Nessie Judge meticulously utilizes various audio elements to enhance the allure and suspense within her content. One of her primary strengths lies in the adept incorporation of sound effects characteristic of the horror genre, such as shrieks, gamelan music, and laughter, to create an atmosphere of unease and tension for the audience. These sound effects not only serve as narrative enhancers but also add a new dimension to the viewing experience, deepening the emotional engagement of the audience with the story being conveyed.

As a storyteller, Nessie also employs a distinct narrative style characterized by a slow and subdued voice. This creates a tense atmosphere and builds anticipation as the story progresses towards its climax. Strategic employment of pauses and emphasis on certain words is also designed to heighten tension and curiosity among the audience. Nessie cleverly utilizes narrative techniques to captivate the audience's attention and keep them riveted to the story. In her content, particularly in "KKN Desa Penari," Nessie employs a deliberate and controlled narrative approach to guide viewers through a chilling journey. The use of suspenseful cliffhangers not only aims to arouse curiosity but also to establish a strong sense of mystery. Thus, Nessie adeptly leverages her unique audio and storytelling style to create a deep and captivating viewing experience for her audience.

The strength of digital storytelling in Nessie Judge's videos encompasses several aspects reflecting her expertise in crafting tension-inducing and intriguing content. Firstly, Nessie emphasizes dark and tense atmospheres through the use of dramatic lighting, appropriate set arrangements, and eerie sound effects. This creates a fitting atmosphere for the conveyed narrative genre and enhances audience engagement. Secondly, Nessie masters the use of cinematic techniques or distinctive editing, such as dramatic cuts, compelling visual effects, and sound manipulation, to create tension. This aids in sustaining audience interest throughout the story and reinforces the desired mysterious impression.



Furthermore, the utilization of two languages, such as English and Indonesian, may be employed to evoke emotional or dramatic effects within the content. The use of English may highlight tension or dramatic moments in the story, while Indonesian is used to provide clarification or additional context. Lastly, Nessie's content demonstrates her ability to seamlessly integrate serious discussions with elements of horror and fear.
